## INSTRUCTIONS FOR ACCESSING THE WORKLIFE PORTAL PROVIDED BY WELLSPAN EAP

1. Please access the portal by going to the WellSpan EAP website <http://www.wellspan.org/eap>, and clicking on the **Work Life Portal** tile on the home page (orange button). You may also access by clicking on the **Resources** tab at the top of the page, then select Work Life Portal from the drop down box.
2. **You'll need to use one of the following browsers to access this portal:**
  - Any version of Firefox, Safari, or Chrome released in 2013 or since then,
  - Internet Explorer 9 or higher,
  - Previous versions of JavaScript enabled browsers should also work.

If you have trouble accessing the portal, your company's computer security filters may be blocking the site, or your computer system may not have a browser that works with the portal. If you are unable to log into the portal please contact your company's IT department for help.
3. You may want to bookmark this website/save it in your favorites, so it's easy to get back to in the future.
4. You will need to register the first time you log into the WorkLife home page. To do that, click on "Register" on the right side of the page.
5. On the next screen, fill out all the required fields, using the following guide:
  - Username = Create a five or more alphanumeric character username
  - Password = Create a five or more alphanumeric character password
  - Passphrase reminder = choose the reminder you prefer
  - Company Code = wsh-eap**

Complete the other fields and check the box about Privacy Terms & Conditions.

Note: *You only need to 'register' the first time you access the WorkLife portal. After that, you can just log in using your username (e-mail address) and the password you chose when registering.*
